#### Achievements:

The conditions on this project resulted in the requirement for numerous significant claims to be produced and submitted. I was responsible for the management and compilation of these claims and when necessary, to co-ordinate with external claims consultants. The claims submitted included extension of time, acceleration, reduction in scope, contesting loss of overhead income and, delayed and non-payment of invoices. Significant and varied variations were also required to be claimed. The project was challenging due to the short project duration and the client (RTA) and consultant.
